

RICH COUNTY DELINQUENT TAX LIST FOR THE YEAR 2011

Unless the delinquent taxes, together with the penalty, are paid before January 31st, the amount of taxes and penalty shall bear interest on a per annum basis from January 1st following the delinquency date.

For each parcel, all delinquent taxes on each separately assessed parcel are subject to a penalty of 1 % of the amount of the taxes or \$10, whichever is greater. However, if the taxes are not paid by Jan. 31st, the greater of a 2.5% or \$10.00 minimum penalty per property parcel will be added to the tax amount.

The following taxes are due and payable along with the penalty to the Rich County Treasurer.
