PART OF THE SOUTHWEST QUARTER OF SECTION 19, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEAST CORNER OF LOT 16, PHASE 2, PLAT "F", BRIDGERLAND VILLAGE AS RECORDED IN THE OFFICE OF THE RICH COUNTY RECORDER;

AND THENCE SOUTH 71°15'36" WEST, 180.16 FEET;
THENCE NORTH 13°42'04" WEST, 210.77 FEET;
THENCE NORTH 33°19'16" EAST, 97.95 FEET;
THENCE NORTH 05°35'31" WEST, 90.42 FEET;
THENCE NORTH 00°35'03" EAST, 228.44 FEET TO THE NORTH LINE OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SAID SECTION 19;
THENCE SOUTH 89°24'57" EAST ALONG THE NORTH LINE OF THE SOUTH HALF OF SAID SECTION 19, 795.13 FEET;
THENCE SOUTH 00°25'42" EAST, 563.69 FEET TO THE NORTH LINE OF CEDAR RIDGE DRIVE;
THENCE SOUTH 75°30'52" WEST, 82.47 FEET;
THENCE SOUTH 00°25'42" EAST, 51.54 FEET TO THE SOUTH LINE OF CEDAR RIDGE DRIVE AND THE NORTH LINE OF PHASE 2, PLAT "F", BRIDGERLAND VILLAGE;
THENCE WESTERLY ALONG THE NORTHERLY LINE OF SAID PHASE 2 IN THE FOLLOWING FOUR COURSES:
1. SOUTH 75°30'52" WEST, 126.06 FEET;
2. 159.84 FEET ALONG A CURVE TO THE LEFT WITH A RADIUS OF 725.00 FEET, INCLUDED ANGLE OF 12°37'54" AND A LONG CHORD THAT BEARS SOUTH 69°11'55" WEST, 159.51 FEET;
3. SOUTH 62°52'57" WEST, 175.55 FEET;
4. NORTH 24°13'14" WEST, 290.58 FEET TO THE BEGINNING.



SURVEY NARRATIVE

1. BASIS OF BEARING FOR THIS SURVEY IS NORTH 00°00'00" WEST ALONG THE WEST LINE OF SECTION 30, TOWNSHIP 14 NORTH, RANGE 5 EAST, SALT LAKE BASE AND MERIDIAN.
2. THE PURPOSE OF THIS SURVEY IS TO DIVIDE A PORTION OF THE NORTHEAST QUARTER OF THE SOUTHWEST QUARTER AND THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 19 TO LOTS AS SHOWN.
3. RETRACEMENT, SOUTHERLY LINES ARE THE NORTH LINE OF PHASE 2, PLAT "F", BRIDGERLAND VILLAGE FROM FOUND MARKERS AND RECORD DIMENSIONS. NORTH LINE IS BY SECTION BREAKDOWN ALLOWING FOR PROPORTIONATE DIMENSIONS TO THE NORTH AND SOUTH HALF OF SAID SECTION 19. EAST AND WEST LINES ARE NEW LINES.
4. 5/8" X 24" REBAR AND CAPS TO BE PLACED FOR LOT CORNERS.


