

EASEMENT "A" LEGAL DESCRIPTION

A PARCEL OF GROUND TO BE USED FOR INGRESS AND EGRESS AS WELL AS UTILITIES LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN, DESCRIBED AS FOLLOWS:

COMMENCING AT THE BRASS CAP MONUMENT FOUND AT THE NORTHWEST CORNER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE SOUTH 89°32'56" EAST 1,376.77 FEET; THENCE SOUTH 00°27'04" WEST 260.44 FEET TO THE TRUE POINT OF BEGINNING; AND RUNNING THENCE NORTH 67°22'20" EAST 58.65 FEET; THENCE SOUTHEASTERLY 498.56 FEET ALONG THE ARC OF A 275.15 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 103°49'01" AND A LONG CHORD THAT BEARS SOUTH 60°43'10" EAST 433.10 FEET; THENCE SOUTH 08°48'40" EAST 53.83 FEET; THENCE SOUTH 81°07'18" WEST 50.00 FEET; THENCE NORTH 08°48'40" WEST 53.89 FEET; THENCE NORTHWESTERLY 407.96 FEET ALONG THE ARC OF A 225.15 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 103°49'01" AND A LONG CHORD THAT BEARS NORTH 60°43'11" WEST 354.40 FEET; THENCE SOUTH 67°22'20" WEST 8.23 FEET; THENCE NORTH 67°52'00" WEST 71.01 FEET TO THE POINT OF BEGINNING. CONTAINING 0.62 ACRES, MORE OR LESS.

A PARCEL OF GROUND LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN, DESCRIBED AS FOLLOWS:

BEGINNING AT THE BRASS CAP MONUMENT FOUND AT THE NORTHWEST CORNER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE SOUTH 89°32'56" EAST 901.11 FEET TO A POINT ON THE TOE OF SLOPE ON THE EAST SIDE OF AN EXISTING CANAL AND THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES NORTH 22°47'04" EAST 332.50 FEET; THENCE SOUTHEASTERLY THE FOLLOWING TWENTY TWO COURSES, 1) EASTERLY 17.80 FEET ALONG THE ARC OF A 332.50 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 03°04'05" AND A LONG CHORD THAT BEARS SOUTH 68°44'58" EAST 17.80 FEET; 2) THENCE SOUTH 70°17'00" EAST 41.68 FEET; 3) THENCE SOUTHEASTERLY 35.47 FEET ALONG THE ARC OF A 360.50 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 05°38'12" AND A LONG CHORD THAT BEARS SOUTH 67°27'54" EAST 35.45 FEET; 4) THENCE SOUTH 64°38'49" EAST 41.50 FEET; 5) THENCE SOUTH 60°22'42" EAST 46.17 FEET; 6) THENCE SOUTHEASTERLY 58.88 FEET ALONG THE ARC OF A 402.50 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 08°22'54" AND A LONG CHORD THAT BEARS SOUTH 56°11'15" EAST 58.83 FEET; 7) THENCE SOUTH 51°59'48" EAST 22.18 FEET; 8) THENCE SOUTHEASTERLY 41.06 FEET ALONG THE ARC OF A 92.00 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 25°34'24" AND A LONG CHORD THAT BEARS SOUTH 39°12'36" EAST 40.72 FEET; 9) THENCE SOUTH 26°25'23" EAST 9.65 FEET; 10) THENCE SOUTHEASTERLY 61.63 FEET ALONG THE ARC OF A 81.00 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 43°35'34" AND A LONG CHORD THAT BEARS SOUTH 48°13'10" EAST 60.15 FEET; 11) THENCE SOUTH 70°00'57" EAST 62.07 FEET; 12) THENCE SOUTH 66°41'33" EAST 59.72 FEET; 13) THENCE SOUTH 71°14'58" EAST 55.93 FEET; 14) THENCE SOUTH 67°52'00" EAST 71.01 FEET TO THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES SOUTH 40°39'45" WEST 93.81 FEET; 15) THENCE SOUTHEASTERLY 84.10 FEET ALONG THE ARC OF A 93.81 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 51°22'03" AND A LONG CHORD THAT BEARS SOUTH 23°39'13" EAST 81.32 FEET; 16) THENCE SOUTH 02°01'47" WEST 49.41 FEET; 17) THENCE SOUTHERLY 100.76 FEET ALONG THE ARC OF A 290.50 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 19°52'24" AND A LONG CHORD THAT BEARS SOUTH 11°57'59" WEST 100.26 FEET; 18) THENCE SOUTH 21°54'11" WEST 31.46 FEET; 19) THENCE SOUTHERLY 84.77 FEET ALONG THE ARC OF A 229.50 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 21°09'47" AND A LONG CHORD THAT BEARS SOUTH 11°19'18" WEST 84.29 FEET; 20) THENCE SOUTH 00°44'25" WEST 30.14 FEET; 21) THENCE SOUTH 02°43'52" EAST 39.62 FEET; 22) THENCE SOUTH 06°53'24" EAST 22.44 FEET; THENCE LEAVING SAID CANAL LINE NORTH 83°06'36" EAST 68.51 FEET; THENCE SOUTH 75°12'32" WEST (SOUTH 75° WEST BY RECORD) 183.31 FEET; THENCE SOUTH 69°55'09" WEST 239.57 FEET; THENCE NORTH 07°49'09" WEST 181.20 FEET TO THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES NORTH 07°49'09" WEST 375.00 FEET; THENCE WESTERLY 54.13 FEET ALONG THE ARC OF A 375.00 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 08°16'14" AND A LONG CHORD THAT BEARS SOUTH 86°18'58" WEST 54.08 FEET; THENCE NORTH 89°32'56" WEST 37.95 FEET; THENCE NORTH 00°27'04" EAST 207.80 FEET; THENCE NORTH 10°39'36" WEST 20.38 FEET; THENCE NORTH 89°32'56" WEST 756.77 FEET; THENCE NORTH 00°08'16" EAST 7.80 FEET; THENCE NORTH 89°51'44" WEST 217.80 FEET TO A POINT ON THE WEST LINE OF SAID NORTHWEST QUARTER SECTION; THENCE NORTH 00°08'16" EAST (NORTH 00°36'54" EAST BY RECORD) ALONG SAID WEST QUARTER SECTION LINE 426.20 FEET TO THE POINT OF BEGINNING. A PARCEL OF GROUND TO BE USED FOR A UTILITY EASEMENT LOCATED IN THE NORTHWEST QUARTER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN, DESCRIBED AS FOLLOWS:

COMMENCING AT THE BRASS CAP MONUMENT FOUND AT THE NORTHWEST CORNER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE SOUTH 89°32'56" EAST 1,783.63 FEET; THENCE SOUTH 00°27'04" WEST 365.44 FEET TO THE TRUE POINT OF BEGINNING; AND RUNNING THENCE NORTH 72°50'37" EAST 223.92 FEET TO A POINT ON THE WEST RIGHT OF WAY LINE OF STATE HIGHWAY 30 AND THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES SOUTH 72°31'58" WEST 1,382.70 FEET; THENCE SOUTHERLY ALONG SAID RIGHT OF WAY LINE 15.00 FEET ALONG THE ARC OF A 1,382.70 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 00°37'18" AND A LONG CHORD THAT BEARS SOUTH 17°09'23" EAST 15.00 FEET; THENCE SOUTH 72°50'37" WEST 221.84 FEET TO THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES SOUTH 68°33'11" WEST 275.15 FEET; THENCE NORTHWESTERLY 15.14 FEET ALONG THE ARC OF A 275.15 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 03°09'13" AND A LONG CHORD THAT BEARS NORTH 25°01'26" WEST 15.14 FEET TO THE POINT OF BEGINNING. CONTAINING 0.08 ACRES, MORE OR LESS.

COMMENCING AT THE BRASS CAP MONUMENT FOUND AT THE NORTHWEST CORNER OF SECTION 33, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE SOUTH 89°32'56" EAST 1,815.59 FEET; THENCE SOUTH 00°27'04" WEST 479.68 FEET TO THE TRUE POINT OF BEGINNING; THENCE NORTH 81°07'18" EAST 135.58 FEET; THENCE NORTH 75°46'07" EAST 87.37 FEET TO A POINT ON THE WEST RIGHT OF WAY LINE OF STATE HIGHWAY 30 AND THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES SOUTH 78°26'53" WEST 1,382.70 FEET; THENCE SOUTHERLY ALONG SAID RIGHT OF WAY LINE 20.03 FEET ALONG THE ARC OF A 1,382.70 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 00°49'48" AND A LONG CHORD THAT BEARS SOUTH 11°08'13" EAST 20.03 FEET; THENCE SOUTH 75°46'07" WEST 87.22 FEET; THENCE SOUTH 81°07'18" WEST 136.54 FEET; THENCE NORTH 08°48'40" WEST 20.00 FEET TO THE POINT OF BEGINNING. CONTAINING 0.10 ACRES, MORE OR LESS.
