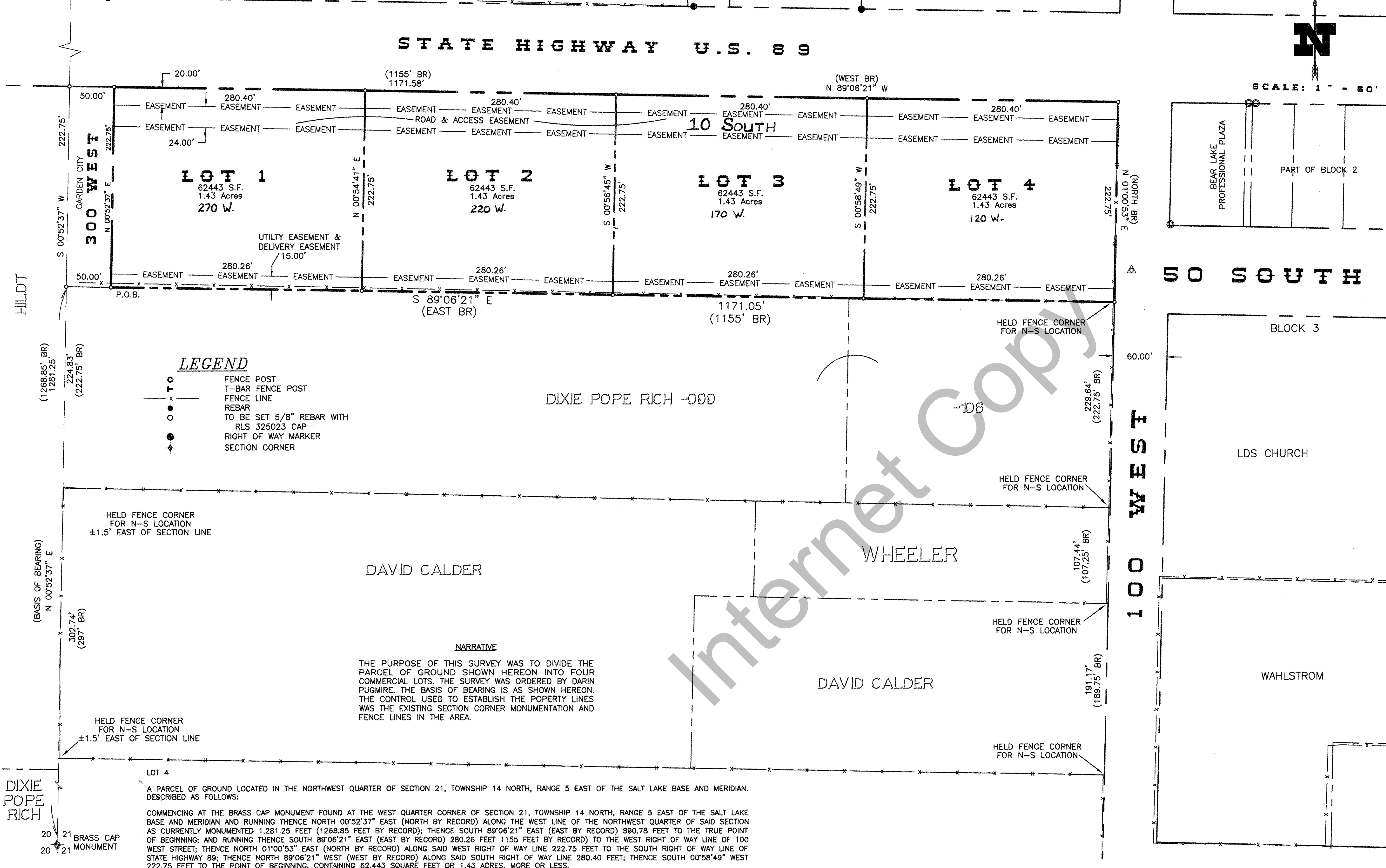

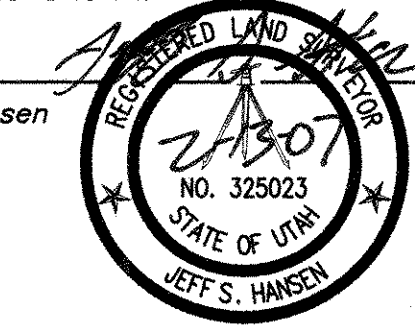

NARRATIVE
THE PURPOSE OF THIS SURVEY WAS TO DIVIDE THE PARCEL OF GROUND SHOWN HEREON INTO FOUR COMMERCIAL LOTS. THE SURVEY WAS ORDERED BY DARIN PUGMIRE. THE BASIS OF BEARING IS AS SHOWN HEREON. THE CONTROL USED TO ESTABLISH THE PROPERTY LINES WAS THE EXISTING SECTION CORNER MONUMENTATION AND FENCE LINES IN THE AREA.

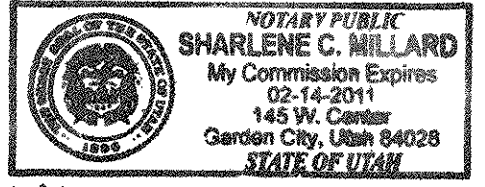
