A PARCEL OF GROUND LOCATED IN SECTIONS 19, 20, 29, & 30 TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN. DESCRIBED AS FOLLOWS:

BEGINNING AT THE CENTER OF SECTION 30, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN AND RUNNING THENCE NORTHERLY ALONG THE EAST LINE OF THE BRIDGERLAND VILLAGE SUBDIVISION PLATS "A" & "D" THE FOLLOWING FOUR COURSES, 1) NORTH 01°20'11" EAST 885.90 FEET (NORTH 01°24' EAST 886.90 FEET BY RECORD); 2) THENCE NORTH 01°22'05" EAST 493.57 FEET (NORTH 01°57' 492.80 FEET BY RECORD); 3) THENCE NORTH 01°53'19" EAST (NORTH 01°54' EAST BY RECORD) 484.36 FEET; 4) THENCE NORTH 03°11'17" EAST 583.86 FEET (NORTH 03°11'26" EAST 583.98 FEET BY RECORD) TO A REBAR WITH A UTAH COUNTY SURVEYOR CAP FOUND AT THE NORTH QUARTER CORNER OF SAID SECTION 30; THENCE CONTINUING NORTHERLY ALONG THE EAST LINE OF THE BRIDGERLAND VILLAGE SUBDIVISION PLAT "D" AND THE PROJECTION THEREOF NORTH 00°03'54" WEST (NORTH 00°03' WEST BY RECORD) 1329.45 FEET TO A POINT ON THE SOUTH LINE OF THE BRIDGERLAND VILLAGE SUBDIVISION PLAT "G" PHASE 1; THENCE SOUTH 89°40'34" EAST ALONG THE SOUTH LINE OF THE BRIDGERLAND VILLAGE SUBDIVISION PLAT "G" PHASE 1 AND TWO 1,299.20 FEET TO THE NORTHEAST CORNER OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 19 OF SAID TOWNSHIP; THENCE SOUTH 01°06'10" EAST 1,323.88 FEET TO THE NORTHERN CORNER OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER OF SAID SECTION 30; THENCE FOLLOWING THE BOUNDARY OF THE NORTHEAST QUARTER OF SAID SECTION 30 THE FOLLOWING TWO COURSES, 1) THENCE SOUTH 01°28'15" WEST 1,272.87 FEET; 2) THENCE SOUTH 87°50'14" EAST 862.16 FEET; THENCE SOUTH 43°04'37" WEST 160.93 FEET; THENCE SOUTHWESTERLY 12.10 FEET ALONG THE ARC OF A 15.00 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 46°13'10" AND A LONG CHORD THAT BEARS SOUTH 66°11'12" WEST 11.77 FEET; THENCE SOUTH 16°53'18" WEST 62.94 FEET; THENCE SOUTH 43°58'38" WEST 303.96 FEET TO A POINT ON THE WESTERLY RIGHT OF WAY LINE OF STATE HIGHWAY 89/91 AND THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES SOUTH 01°49'26" WEST 705.00 FEET; THENCE SOUTHWESTERLY ALONG SAID RIGHT OF WAY LINE THE FOLLOWING FOUR COURSES, 1) SOUTHWESTERLY 693.32 FEET ALONG THE ARC OF A 705.00 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 56°20'48" AND A LONG CHORD THAT BEARS SOUTH 63°39'02" WEST 665.72 FEET TO THE POINT OF CURVE OF A NON TANGENT CURVE OF WHICH THE RADIUS POINT LIES SOUTH 42°13'25" EAST 360.00 FEET; 2) THENCE SOUTHWESTERLY 219.46 FEET ALONG THE ARC OF A 360.00 FOOT RADIUS CURVE TO THE LEFT THROUGH A CENTRAL ANGLE OF 34°55'39" AND A LONG CHORD THAT BEARS SOUTH 30°18'45" WEST 216.07 FEET; 3) THENCE SOUTH 12°59'14" WEST 257.06 FEET; 4) THENCE SOUTH 12°50'15" WEST 92.62 FEET TO A POINT ON THE NORTH LINE OF THE BRIDGERLAND VILLAGE SUBDIVISION PLAT "A"; THENCE NORTH 85°37'51" WEST (NORTH 85°36' WEST BY RECORD) ALONG THE NORTH LINE OF THE BRIDGERLAND VILLAGE SUBDIVISION PLAT "A" 1,102.12 FEET (1102.48 FEET BY RECORD) TO THE POINT OF BEGINNING.
