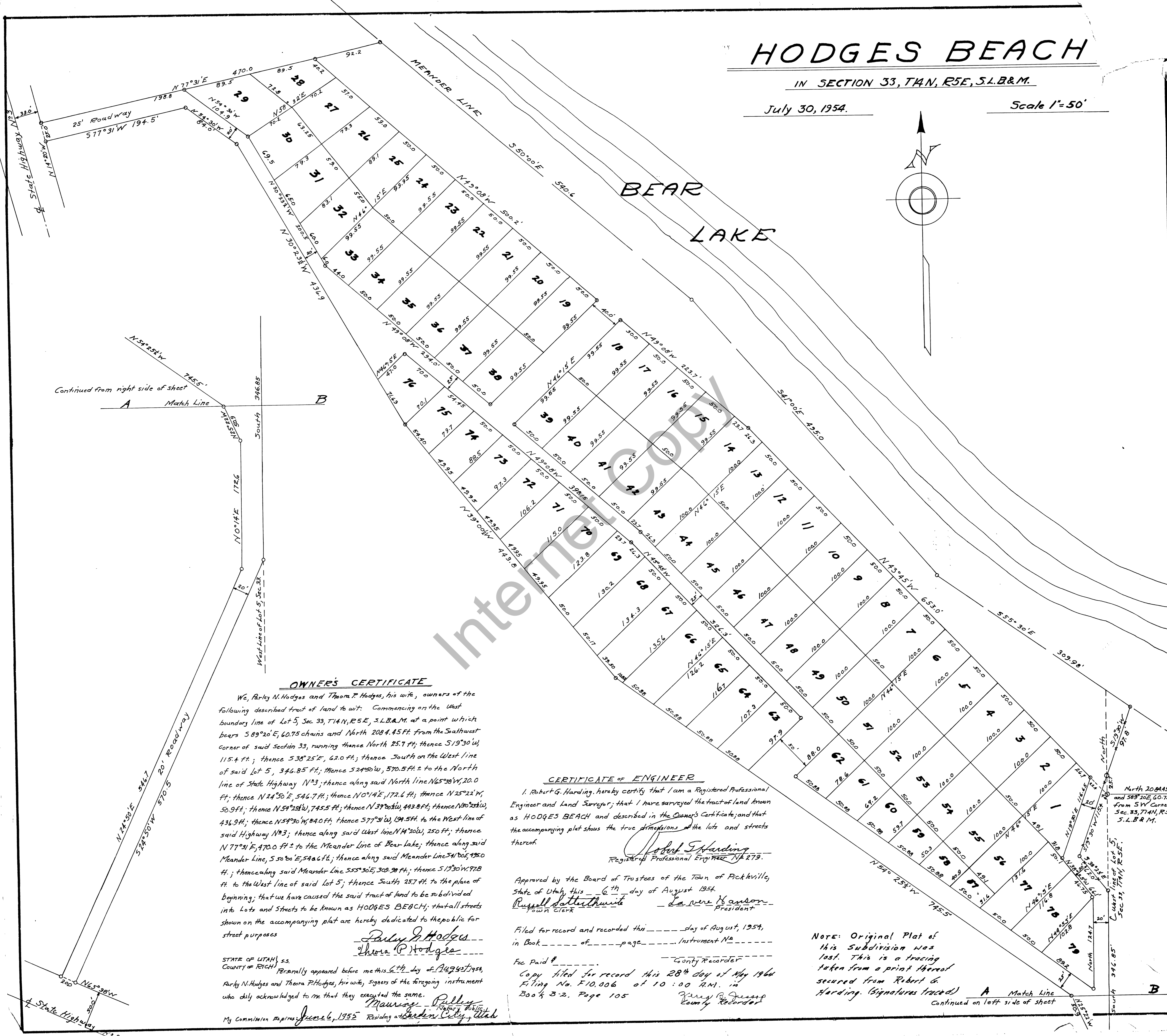
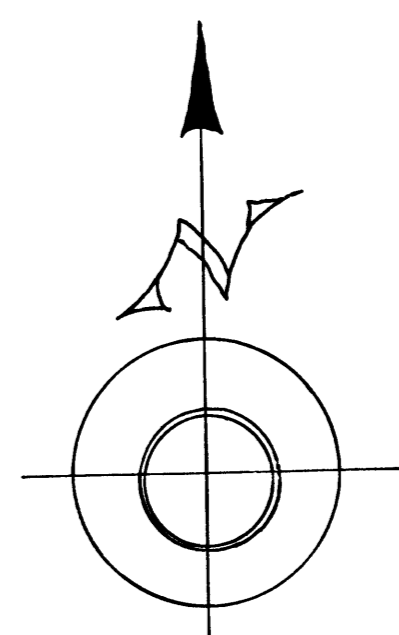


HODGES BEACH

OWNER'S CERTIFICATE

We, Parley N. Hodges and Theora P. Hodges, his wife, owners of the following described tract of land to wit: Commencing on the West boundary line of Lot 5, Sec. 33, T4N, R5E, S.L.B.&M. at a point which bears S 89° 20' E, 60.75 chains and North 2084.45 ft. from the Southwest corner of said Section 33, running thence North 25.7 ft.; thence S 19° 30' W, 115.4 ft.; thence S 38° 25' E, 62.0 ft.; thence South on the West line of said Lot 5, 346.85 ft.; thence S 24° 50' W, 570.5 ft. to the North line of State Highway N° 3; thence along said North line N 65° 38' W, 20.0 ft.; thence N 24° 50' E, 546.7 ft.; thence N 10° 14' E, 172.6 ft.; thence N 25° 22' W, 50.9 ft.; thence N 54° 30' W, 745.5 ft.; thence N 39° 30' W, 443.8 ft.; thence N 80° 20' W, 436.9 ft.; thence N 54° 30' W, 84.0 ft.; thence S 77° 31' W, 194.5 ft. to the West line of said Highway N° 3; thence along said West line N 14° 20' W, 250 ft.; thence N 77° 31' E, 470.0 ft. to the Meander Line of Bear Lake; thence along said Meander Line, S 50° 30' E, 546.6 ft.; thence along said Meander Line S 41° 00' E, 495.0 ft.; thence along said Meander Line S 55° 30' E, 309.9 ft.; thence S 19° 30' W, 718 ft. to the West line of said Lot 5; thence South 25.7 ft. to the place of beginning; that we have caused the said tract of land to be subdivided into Lots and Streets to be known as HODGES BEACH; that all streets shown on the accompanying plat are hereby dedicated to the public for street purposes
