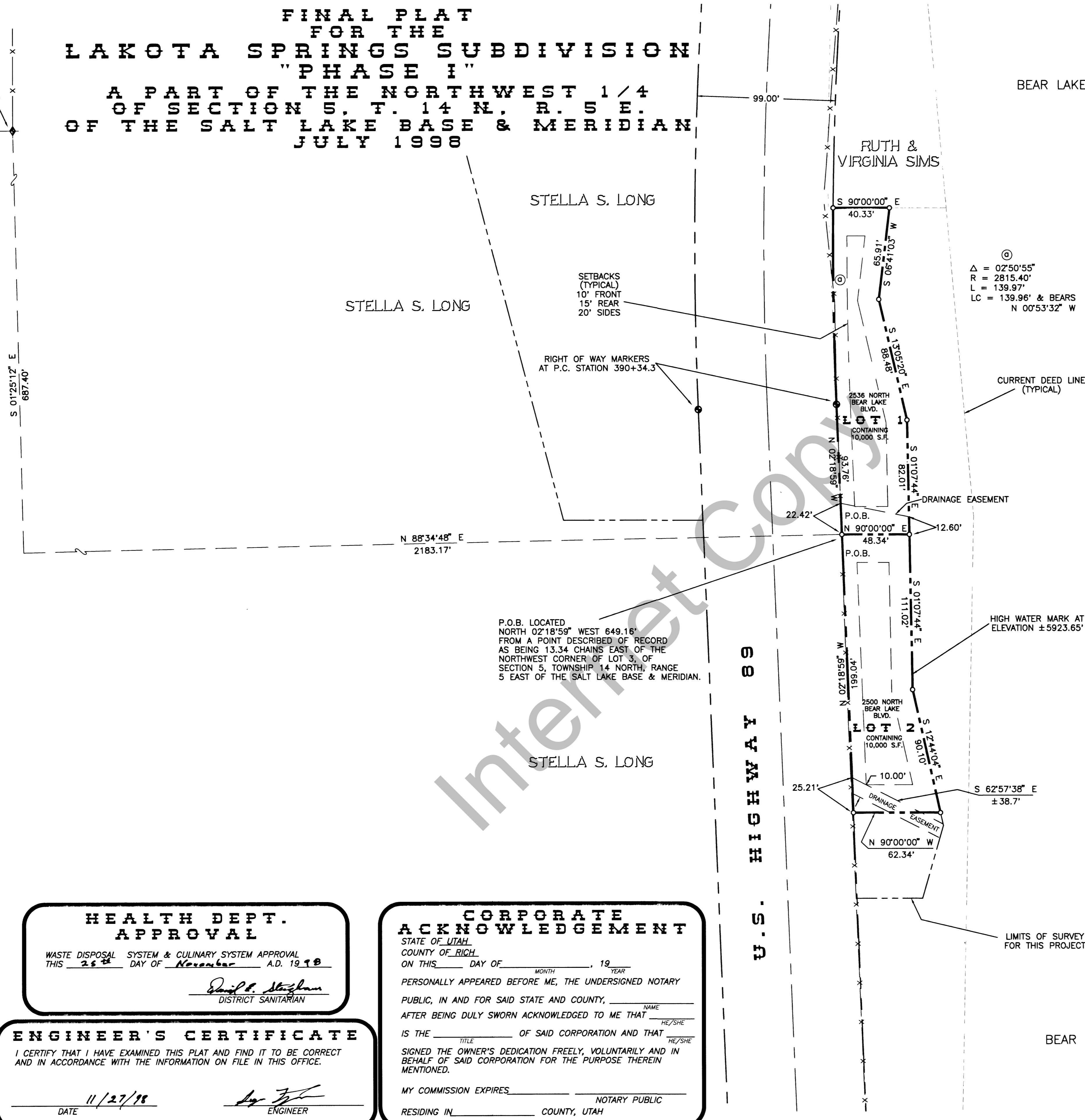

BOUNDARY DESCRIPTION

A PART OF THE NORTHWEST QUARTER OF SECTION 5, TOWNSHIP 14 NORTH, RANGE 5 EAST, OF THE SALT LAKE BASE AND MERIDIAN, DESCRIBED AS FOLLOWS:
BEGINNING AT A POINT LOCATED IN THE EAST RIGHT OF WAY LINE OF U.S. HIGHWAY 89 IN RICH COUNTY, UTAH AT ENGINEERS STATION 389+40.54 49.50 FEET RIGHT, SAID POINT BEING LOCATED SOUTH 01°25'12" EAST 687.40 FEET AND NORTH 88°34'48" EAST 2183.17 FEET FROM THE REBAR MONUMENT SET AT A FENCE CORNER AT THE NORTHWEST CORNER OF SECTION 5, TOWNSHIP 14 NORTH, RANGE 5 EAST OF THE SALT LAKE BASE AND MERIDIAN, SAID POINT OF BEGINNING BEING LOCATED NORTH 02°18'59" WEST 649.16 FEET OF A POINT DESCRIBED OF RECORD AS BEING 13.34 CHAINS EAST OF THE NORTHWEST CORNER OF LOT 3 OF SAID SECTION, AND RUNNING THENCE NORTHERLY ALONG THE AFORESAID EAST RIGHT OF THE FOLLOWING TWO COURSES, NORTH 02°18'59" WEST 93.76 FEET; THENCE NORTHWESTERLY 139.97 FEET ALONG THE ARC OF A 2815.40 FOOT RADIUS CURVE TO THE RIGHT THROUGH A CENTRAL ANGLE OF 02°50'55" AND A LONG CHORD THAT BEARS NORTH 00°53'32" WEST 139.96 FEET; THENCE NORTH 90°00'00" EAST 40.33 FEET TO THE HIGH WATER LINE OF BEAR LAKE; THENCE SOUTHERLY ALONG SAID HIGH WATER LINE THE FOLLOWING FIVE COURSES, SOUTH 06°41'03" WEST 65.91 FEET; THENCE SOUTH 13°05'20" EAST 88.48 FEET; THENCE SOUTH 01°07'44" EAST 193.03 FEET; THENCE SOUTH 12°44'04" EAST 90.10 FEET; THENCE LEAVING SAID HIGH WATER LINE SOUTH 90°00'00" WEST 62.34 FEET TO THE AFORESAID EAST HIGHWAY RIGHT OF WAY LINE; THENCE NORTH 02°18'59" WEST 199.04 FEET TO THE POINT OF BEGINNING. CONTAINING 0.46 ACRES AND TWO LOTS.
