LEGAL DESCRIPTION
OF A
MOUNTAIN MEADOW SUBDIVISION PARCEL AND ACCESS ROAD
QUESTAR PIPELINE COMPANY
ROCK SPRINGS, WYOMING
MAY 1996

A subdivision parcel of land in two phases and a 50 feet wide strip of land for access roads in three parts situated in the east half of the southeast quarter of Section 20, Township 10 North, Range 7 East, Salt Lake Meridian, Rich County, Utah, being a brass cap and iron pipe monument, being more particularly described as follows:

PHASE 1
Commencing at the section corner common to Sections 20, 21, 28 and 29, Township 10 North, Range 7 East, Salt Lake Meridian, Rich County, Utah, being a brass cap and iron pipe monument, thence N.01°11'38"W, 1,184.95 feet to the POINT OF BEGINNING, a point on the westerly right of way boundary for Utah State Highway No. 16, and the southeasterly corner of the Mountain Meadow Subdivision Phase 1;
Thence southwesterly through a curve concave from the northwest, with a delta angle of 21°16'54", a radius of 439.21 feet, a length of 163.14 feet, a chord length of 162.21 feet and a tangent length of 82.52 feet to a set aluminum cap and iron bar monument;
Thence N.89°55'16"W, 892.84 feet to the corner of a fenced parcel of land for a water well and pump house and a set aluminum cap and iron bar monument;
Thence continuing N.89°55'16"W, 122.12 feet to the southwest corner of Mountain Meadow Subdivision Phase 1, the corner of a fenced parcel of land for a water well and pump house and a set aluminum cap and iron bar monument;
Thence N.00°00'43"E, 64.02 feet to the corner of a fenced parcel of land for a water well and pump house and a set aluminum cap and iron bar monument;
Thence continuing N.00°00'43"E, 780.55 feet to the northwest corner of Mountain Meadow Subdivision and a set aluminum cap and iron bar monument;
Thence N.89°55'16"W, 833.57 feet to the northeast corner of Mountain Meadow Subdivision, a point on the westerly right of way boundary for Utah State Highway No. 16, and a found aluminum cap and iron bar monument;
Thence S.22°42'50"E, 64.59 feet along said westerly right of way boundary to the POINT OF BEGINNING.

PHASE 2
Commencing at the section corner common to Sections 20, 21, 28 and 29, Township 10 North, Range 7 East, Salt Lake Meridian, Rich County, Utah, being a brass cap and iron pipe monument and the POINT OF BEGINNING, the southeasterly corner of Mountain Meadow Subdivision;
Thence S.89°55'16"W, 1,199.91 feet to the southeasterly corner of Mountain Meadow Subdivision and a found aluminum cap and iron bar monument;
Thence N.00°00'43"E, 1,153.53 feet to the corner of a fenced parcel of land for a water well and pump house and a set aluminum cap and iron bar monument;
Thence S.89°55'16"W, 122.12 feet to the southeast corner of a fenced parcel of land for a water well and pump house and a set aluminum cap and iron bar monument;
Thence S.89°55'16"W, 892.84 feet to the southeast corner of a fenced parcel of land for a water well and pump house and a set aluminum cap and iron bar monument;
Thence northwesterly through a curve concave from the northwest, with a delta angle of 21°16'54", a radius of 439.21 feet, a length of 163.14 feet, a chord length of 162.21 feet and a tangent length of 82.52 feet to the junction with Road No. 1 for Mountain Meadow Subdivision;
Thence S.22°42'50"E, 64.59 feet along said westerly right of way boundary to the POINT OF BEGINNING.

ACCESS ROAD PART 1
Commencing at the section corner common to Sections 20, 21, 28 and 29, Township 10 North, Range 7 East, Salt Lake Meridian, Rich County, Utah, being a brass cap and iron pipe monument, thence N.01°28'13"E, 1,179.50 feet to the POINT OF BEGINNING, a point in the centerline of Utah State Highway 16 and the junction with the Road No. 1 for Mountain Meadow Subdivision;
Thence southwesterly through a curve concave from the northwest, with a delta angle of 22°13'01", a radius of 465.67 feet, a length of 180.65 feet, a chord length of 173.52 feet, a tangent length of 91.47 feet, and Station 1+80.65 on said Road No. 1;
Thence S.89°55'16"W, 602.86 feet to the junction with Road No. 2 for Mountain Meadow Subdivision and Station 7+83.51 on said Road No. 1;
Thence continuing S.89°55'16"W, 269.56 feet to the junction with Road No. 3 for Mountain Meadow Subdivision and Station 10+53.07 on said Road No. 1;
Thence continuing S.89°55'16"W, 145.28 feet to the end and Station 11+98.35 on said Road No. 1.

ACCESS ROAD PART 2
Commencing at the junction with Road No. 1 for Mountain Meadow Subdivision, Station 7+83.51 on said Road No. 1, the POINT OF BEGINNING and Station 0+00 on Road No. 2 for Mountain Meadow Subdivision;
Thence S.00°00'08"W, 223.97 feet to Station 2+23.97 on said Road No. 2;
Thence southwesterly through a curve concave from the northeast, with a delta angle of 29°05'11", a radius of 350.51 feet, a length of 183.12 feet, a chord length of 181.16 feet, a tangent length of 93.58 feet, to Station 4+07.09 on said Road No. 2;
Thence southerly through a curve concave from the southwest, with a delta angle of 28°59'00", a radius of 355.74 feet, a length of 166.97 feet, a chord length of 165.45 feet, a tangent length of 85.04 feet, to Station 5+74.06 on said Road No. 2;
Thence S.00°09'18"W, 209.85 feet to the end of said Road No. 2, junction with Road No. 3 for Mountain Meadow Subdivision, Station 11+71.59 on said Road No. 3, and Station 7+83.91 on said Road No. 2.

ACCESS ROAD PART 3
Commencing at the junction with Road No. 1 for Mountain Meadow Subdivision, Station 10+53.07 on said Road No. 1, the POINT OF BEGINNING and Station 0+00 on Road No. 3 for Mountain Meadow Subdivision;
Thence S.00°02'15"W, 344.97 feet to Station 3+44.97 on said Road No. 3;
Thence southwesterly through a curve concave from the northeast, with a delta angle of 34°48'57", a radius of 145.21 feet, a length of 88.24 feet, a chord length of 86.89 feet, a tangent length of 45.53 feet, to Station 4+33.21 on said Road No. 2;
Thence southwesterly through a curve concave from the west, with a delta angle of 84°09'37", a radius of 178.52 feet, a length of 262.22 feet, a chord length of 239.28 feet, a tangent length of 161.19 feet, to Station 6+95.43 on said Road No. 3;
Thence southerly through a curve concave from the southeast, with a delta angle of 29°18'12", a radius of 145.21 feet, a length of 74.27 feet, a chord length of 73.46 feet, a tangent length of 37.96 feet, to Station 7+69.70 on said Road No. 3;
Thence S.00°47'30"W, 37.92 feet to Station 8+07.62 on said Road No. 3;
Thence S.89°45'02"E, 363.97 feet to Station 11+71.59 on said Road No. 3 and the junction with said Road No. 2;
Thence continuing S.89°45'02"E, 40.44 feet to the end and Station 12-03 on said Road No. 3.

The total area of Mountain Meadow Subdivision, Phase 1, as described above, is 854,600 square feet or 19.62 acres, more or less.
The total area of Mountain Meadow Subdivision, Phase 2, as described above, is 1,384,300 square feet or 31.78 acres, more or less.
The total length of access roads as described, is 3,194.29 feet or 193.59 rods or 0.61 mile, more or less.

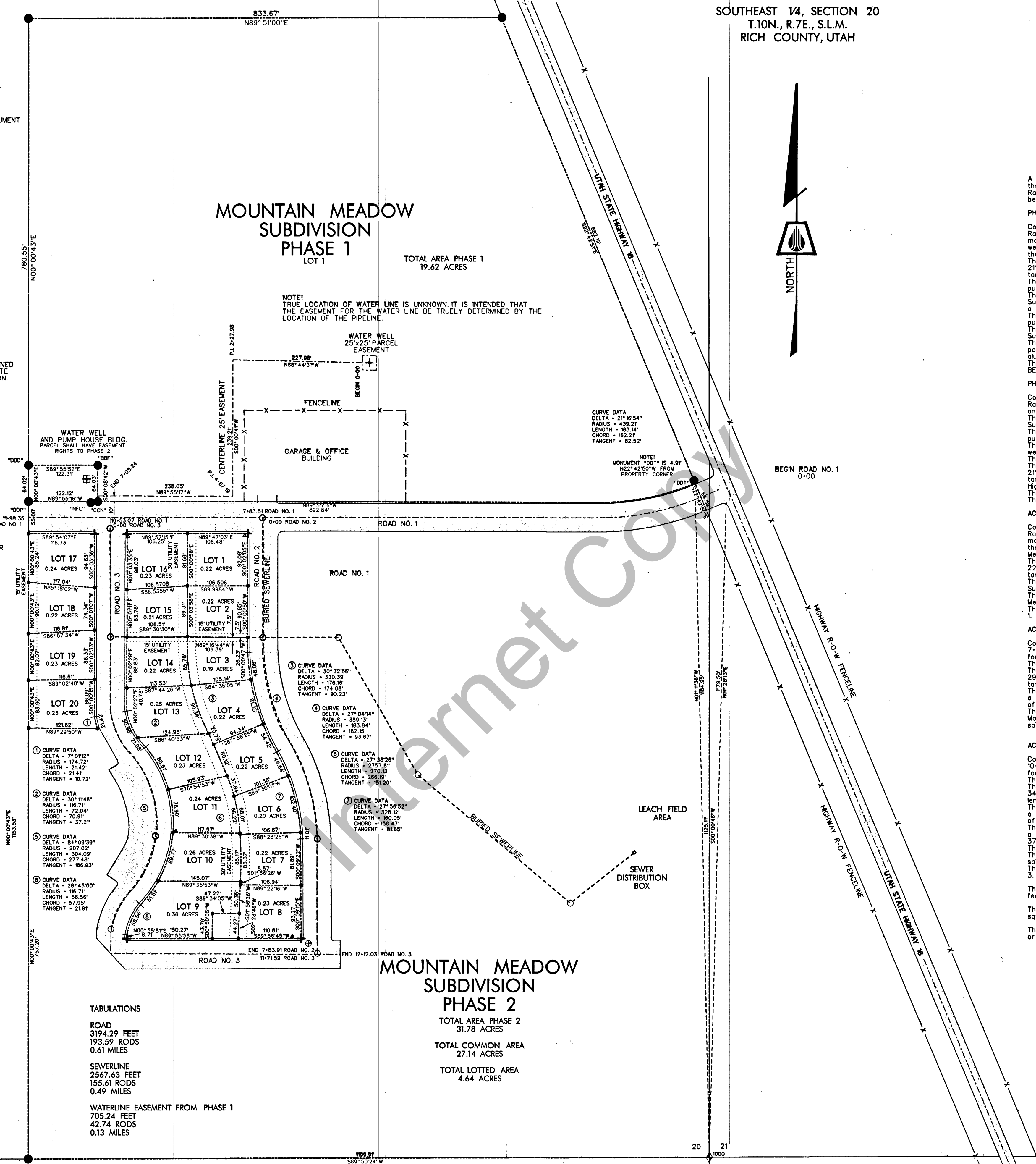
