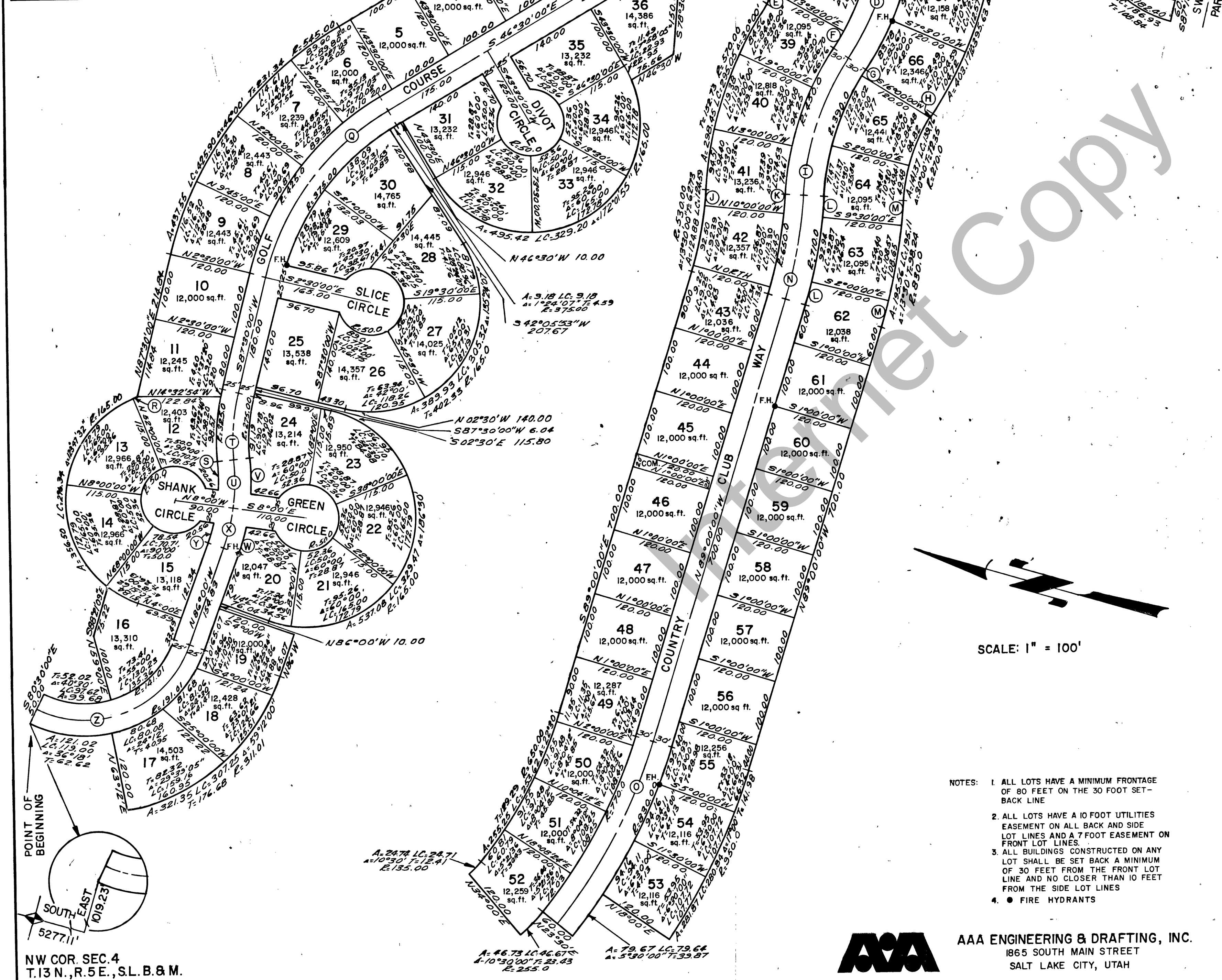

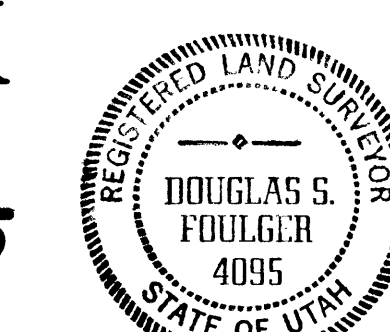
**SURVEYOR'S CERTIFICATE**

I, Douglas S. Foulger, do hereby certify that I am a registered Land Surveyor and that I hold Certificate No. 4095 as prescribed under the laws of the State of Utah. I further certify that by the authority of the owners, I have plotted the subdivision of the tract shown here and have divided said tract of land into lots and streets, hereafter to be known as Sweetwater Park Golf Course Subdivision No. 5 and that same will be correctly staked on the ground as shown on this plat.
