

SURVEYOR'S CERTIFICATE

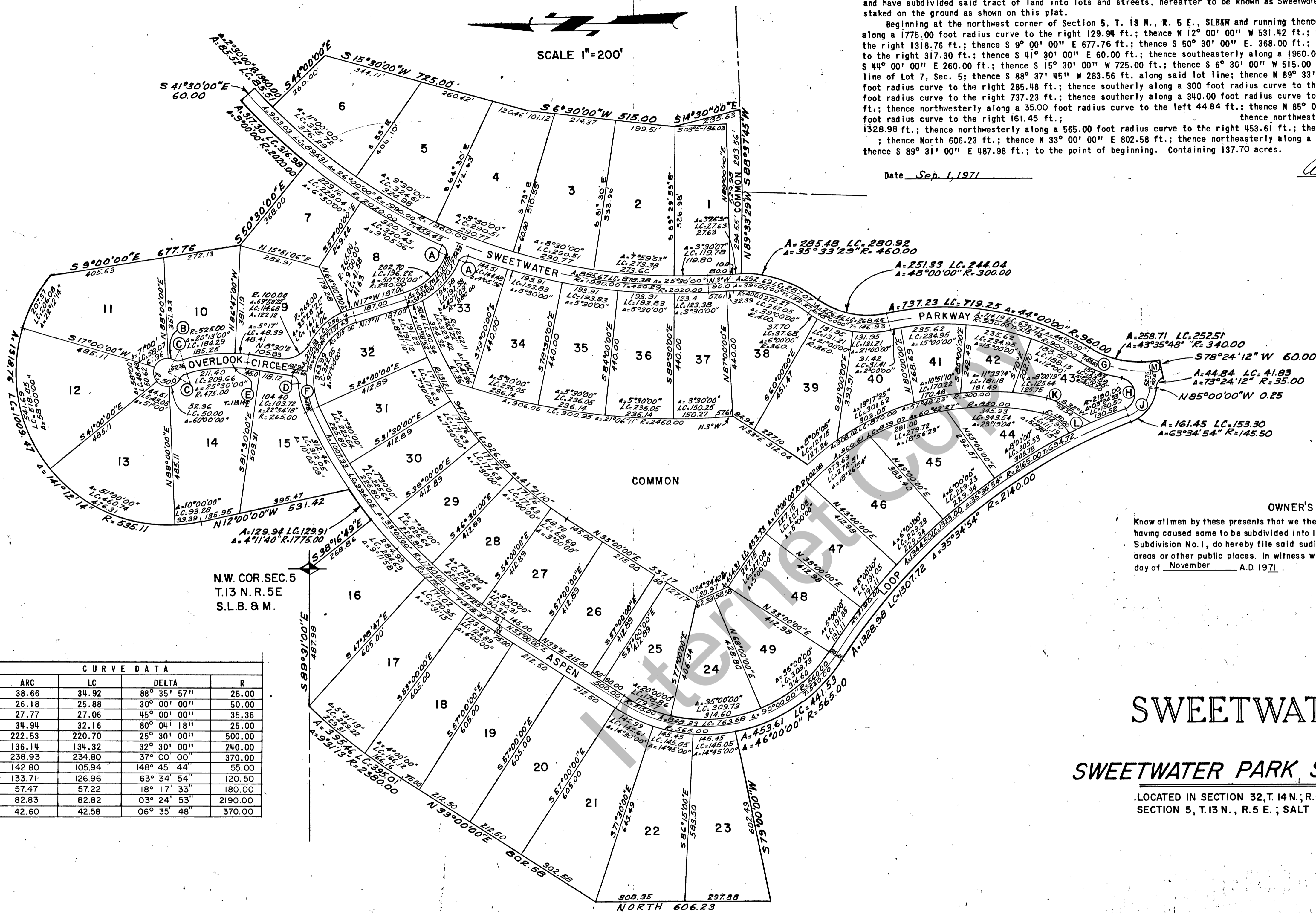
