



DESCRIPTION

Part of the S 1/2 Section 3 and the N 1/2 Section 10, T. 13 N., R. 5 E., S. L. B. & M. described as follows: Beginning at a point which lies East 136.11 feet and South 1188.82 feet from the Southwest corner of Lot 5 of said Section 3 and running thence East 221.00 feet; thence South 515.00 feet; thence East 412.00 feet; thence N 45° 00' 00" E 255.00 feet; thence South 950.00 feet; thence West 813.31 feet; thence North 1284.69 feet to the point of beginning containing 17.36 acres more or less.

RIGHT-OF-WAY

Part of the S 1/2 Section 3 and the N 1/2 Section 10, T. 13 N., R. 5 E., S. L. B. & M. described as follows: Beginning at a point which lies South 605.78 feet and West 554.17 feet from the SW corner of Lot 5 of said Section 3; said point also described as being on the east side of a county road; and running thence S 50° 00' 00" E 232.50 ft. to a point of curve thence southeasterly 161.04 ft. along a 221.00 foot radius curve to the left; thence N 88° 15' 00" E 168.00 ft. to a point of curve thence southeasterly 191.31 ft. along a 237.00 foot radius curve to the right; thence S 45° 30' 00" E 292.00 ft. to a point of curve; thence Southeasterly 217.58 ft. along a 351.00 ft. radius curve to the left to a point on said curve (radial bearing N 8° 59' 01" E); thence S 12° 15' 00" W 58.62 ft. to a point of curve; thence Southerly 153.92 ft. along a 244.40 ft. radius curve to the left to a point of tangency; thence S 23° 50' 00" E 155.59 ft. to a point of curve; thence Easterly 91.74 ft. along a 55.00 ft. radius curve to the left; thence S 29° 24' 11" E 40.00 ft.; thence S 17° 15' 00" E 128.28 ft. to the North boundary of Phase IV; thence West 41.88 ft.; thence N 17° 15' 00" W 115.86 ft. to a point (radial bearing N 5° 05' 48" W) on a 95.00 ft. radius curve to the right; thence Northwesterly along said curve 118.16 ft. to a point of tangency; thence N 23° 50' 00" W 155.59 ft. to a point of curve; thence Northerly 179.11 ft. along a 284.40 ft. radius curve to the right to a point of reverse curve (radial bearing N 77° 45' 00" W); thence Northwesterly 29.47 ft. along a 20.00 ft. radius curve to the left to a point of reverse curve (radial bearing N 17° 50' 06" E); thence Northwesterly 69.83 ft. along a 391.00 ft. radius curve to the right to a point (radial bearing N 28° 04' 05" E) on said curve; thence S 31° 00' 00" W 52.84 ft. to the South line of said Trailer-Camper Park; thence North 25.35 ft. along said line; thence West 31.43 ft. along said line; thence N 31° 00' 00" E 47.30 ft. to a point (radial bearing N 33° 55' 55" E) on a 391.00 ft. radius curve to the right; thence Northwesterly along said curve 72.12 ft. to a point of tangency; thence N 45° 30' 00" W 292.00 ft. to a point of curve; thence Northwesterly 159.02 ft. along a 197.00 foot radius curve to the left; thence S 88° 15' 00" W 168.00 ft. to a point of curve; thence northwesterly 190.18 ft. along a 261.00 foot radius curve to the right; thence N 50° 00' 00" W 232.50 ft. to the east side of a county road; thence N 40° 00' 00" E 40.00 ft. along said county road to the point of beginning.
