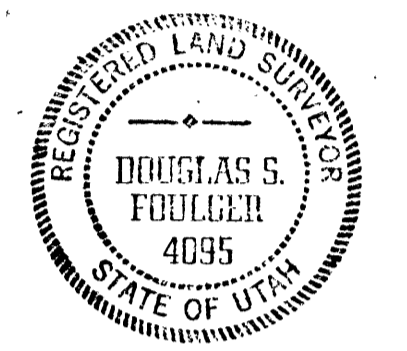

EDGEMONT DRIVE

Beginning at a point on the East right-of-way of a county road said point lying S 42°27'09" 821.02 ft. from the SW corner of Lot 5, Section 3, T. 13 N., R. 5 E., S.L.B. & M. and running thence S 50°00'00" E 232.50 ft., thence 161.04 ft. Easterly along a 221 ft. radius curve to the left of radial bearing N 40°00'00" E, thence N 88°15'00" E 142.33 ft., thence South 40.02 ft., thence S 88°11'00" W 141.11 ft., thence 190.18 ft. Westerly along a 261 ft. radius curve to the right of radial bearing N 01°45'00" E, thence N 50°00'00" W 232.50 ft., thence N 40°00'00" E 40 ft. to the point of beginning.

BREEZE WAY

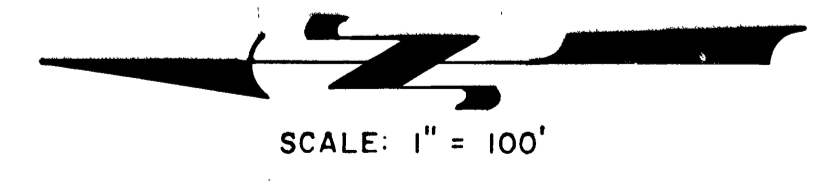

Easterly along a 384 ft. radius curve to the right of radial bearing S 19°00'00" W to a point of reverse curve, thence 141.13 ft. Easterly along a 790 ft. radius curve to the left, thence South 52.45 ft., thence 183.05 ft. Westerly along a 830 ft. radius curve to the right of radial bearing N 39°06'50" E to a point of reverse curve, thence 196.63 ft. Westerly along a 344 ft. radius curve to the left, thence N 19°00'00" E 40 ft. to the point of beginning.
