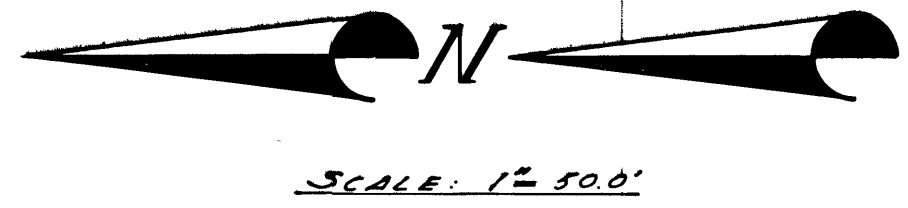


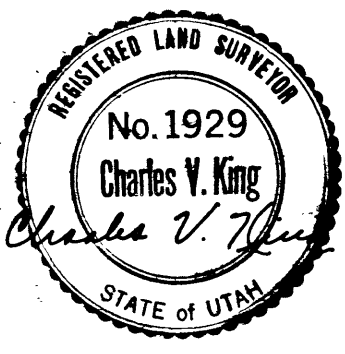

SURVEYOR'S CERTIFICATE

I, CHARLES V. KING, DO HEREBY CERTIFY THAT I AM A REGISTERED PROFESSIONAL ENGINEER AND LAND SURVEYOR, AND THAT I HOLD CERTIFICATE NO. 1929, AS PRESCRIBED UNDER THE LAWS OF THE STATE OF UTAH. I FURTHER CERTIFY THAT BY AUTHORITY OF THE OWNERS, I HAVE MADE A SURVEY OF THE TRACT OF LAND SHOWN ON THIS PLAT AND DESCRIBED BELOW, AND HAVE SUBDIVIDED SAID TRACT OF LAND INTO LOTS AND STREETS, HEREAFTER TO BE KNOWN AS SHORE LODGE ESTATES, AND THAT SAME HAS BEEN CORRECTLY SURVEYED AND STAKED ON THE GROUND AS SHOWN ON THIS PLAT.



BOUNDARY DESCRIPTION

BEGINNING AT A POINT WHICH IS 1792.51' EAST ALONG THE SECTION LINE FROM THE N.W. COR. OF SEC. 28, T. 14 N., R. 5 E., S. 4 B. 1 M. AND RUNNING THENCE EAST 236.17' MORE OR LESS TO THE MEANDER LINE OF BEAR LAKE; THENCE S. 16° 22' 12" W. 1360.00' ALONG SAID MEANDER LINE TO THE SOUTH LINE OF LOT 1 IN SEC. 28; THENCE WEST ALONG SAID LOT LINE 236.17' MORE OR LESS TO THE EAST RIGHT OF WAY LINE OF A STATE HIGHWAY; THENCE N. 16° 22' 12" E. ALONG SAID HIGHWAY RIGHT OF WAY LINE 1360.00' TO THE POINT OF BEGINNING.

NOTE: BEARINGS AND DISTANCES MARKED WITH AN ASTERISK (*) MAY BE SUBJECT TO VARIATION IN THE FUTURE BECAUSE THE EASTERLY PROPERTY LINE IS DEFINED AS THE MEANDER LINE OF BEAR LAKE. DISTANCES AND BEARINGS SHOWN REPRESENT THE CONDITIONS AS THEY EXISTED AT THE TIME THIS PLAT WAS PREPARED.
