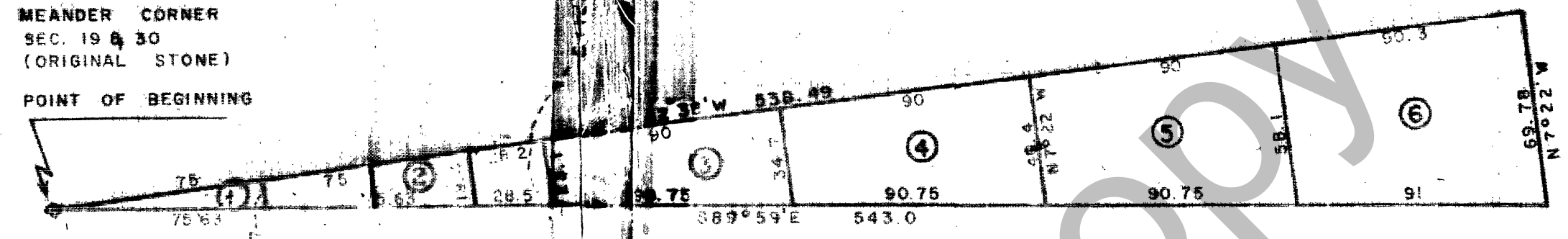


Scale 1" = 50'
